

**Valley Regional Transit, Annual Bus Pass and \$50 Downtown Boise Association Gift Card Giveaway Official Rules
NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. THE PROMOTION BEGINS ON
January 28, 2019 AND ENDS ON May 1, 2019.**

1. **ELIGIBILITY:** Valley Regional Transit Annual Bus Pass and \$50 Downtown Boise Association Gift Card Giveaway Official Rules (“Promotion”) is open to legal residents of the 50 United States and the District of Columbia who are 18 years of age or older at the time of entry. Void where prohibited.
